**General Information:**

1. **RV PARK SPACE.** RV park spaces will be assigned on a first come first serve basis. NWKDFP reserves the right to assign space location, and will consider the preference, if any, of the lessee. RV park opens at 12:00 pm MT (Noon) on the Friday prior to fair week (period stated above). Cost of a RV park space is \$125.00 for the period stated above.
2. **SERVICES.** The only service that NWKDFP provides is electricity. NWKDFP will not provide any extension cords. None of the spaces are equipped with water, gas, or sewage.
3. **TRASH.** Dumpster located in the park is for personal trash only. All garbage must be bagged & tied, boxes broken down. DO NOT leave trash outside by your RV.
4. **QUIET TIME.** 10 p.m. / 7 a.m. – please be considerate of others. No loud music at any time.
5. **PARKING.** Two vehicles only per RV space if your space is large enough. Please park parallel to your RV out of the main drives.
6. **CONDUCT.** Disorderly conduct, drunkenness, illegal drugs, obscene language, obnoxious, disruptive, or vulgar behavior will not be tolerated. They will be reason for immediate eviction without refund.
7. **DRUGS.** Illegal drugs of any form are prohibited on the property of RV park. Person(s) caught in violation of this rule are subject to immediate eviction without a refund. Person (s) knowing of any illegal activity are encouraged to notify the management immediately. Any information reported will be strictly confidential.
8. **LIABILITY.** All park facilities and equipment of the park is intended for the convenience of the guests. All persons using the facilities do at THEIR OWN RISK and consent. The park management is NOT RESPONSIBLE for accident due to fire, theft, wind, flood, personal negligence, acts of God or other unfortunate circumstances. The registered guest is financially responsible for all individuals or pets at their site for any/all damage to the park.
